We apply rough sets to characterize definable subsets of the universe of the information system.

O. INTRODUCTION

Approximate classification of objects is an important task in various fields. Formal tools dedicated to deal with such class of problems are offered by fuzzy sets theory of Zadeh ([6]) and tolerance theory of Zeeman ([7]). Another proposal for approximate classification has been considered in [4] where the notion of a rough (approximate) set is the departure point of the proposed method. The method is based on the upper and lower approximation of a set.

The approximation operations on sets are closely related to the theory of subsystems of the information system as developed in ours [3]. The approximation approach allows to explain some facts concerning the embeddings of algebras of describable sets. This problem is considered in detail in this note. For the completeness sake we recapitulate the basic properties of rough sets in the section 1.

1. PRELIMINARIES

Let X be a set, called an universum and $\triangle = \langle X, D, A, U \rangle$ be an information system on the set X. With the system \triangle we adjoin a language \mathcal{L}_{\triangle} . This formal language allows us to describe some subsets of the sets X. The describable sets form a Boolean algebra $\mathcal{B}(\triangle)$. The atoms of this algebra are called constituents of the system \triangle or elementary sets in \triangle . These sets are nonempty and pairwise disjoint. Every describable set is a finite union of elementary sets.

Let Z be a subset of the set X. The least describable $T \subseteq X$ such that $Z \subseteq T$ exists and is called best upper approximation of Z in O or closure of Z and denoted by \overline{Z} . Analogously the largest describable subset $T \subseteq X$ such that T ≤ Z again exists and is called best lower approximation of Z in O or interior of Z and is denoted by Z.

The set $Fr(X) = \overline{X} - \underline{X}$ is called the boundary of X in \Im . The set $E(X) = \tilde{X} - X$ is called the edge of X in \Im . As is easily seen the operation - is a closure operation in the sense of Kuratowski, . is the adjoint interior operation. This means that the following facts are true:



We define two additional membership relations \in and $\widetilde{\epsilon}$ called strong and weak membership as follows:

Those have clear meanings: "x definitely is in X" and "x is possibly in X^n . They may be interpreted as $\langle \rangle x \in X$ and I x &X in the sense of model logic.

The sets with the property $X \simeq 0$ are called loose sets, the boundary of X is always loose.

We list below a couple more properties of \simeq and \sim :

This means that if we restrict our system to a definable subset then the constituent to not change or vanish.

We have the following relationship between the sets 2 and Z :

Proof: Let us investigate \overline{Z} . It happens that $x \in \overline{Z}$ exactly in the case when there exists a constituent \overline{T} oif the system C (i.e. the value of a primitive term) such that $x \in \overline{T}$ and $\overline{T} \cap \overline{Z} \neq \emptyset$. We discuss for a moment selective systems. The following is fairly simple.

Now let us investigate how the operations . and _ believe with respect to subsystem and extensions. Notice first that if $0_1 \le 0_2$ then the operation _ in 0_1 is not the trace of _ in 0_2 . We investigate the relationship between the algebras $\mathcal{B}(\triangle)$? and $\mathcal{B}(\triangle)$. The following characterization result was proved independently by M. Jaegermann (oral communication):

Proof: (i) => (ii). This follows from calculating the number of generators of the algebras under consideration, i.e. the number of non-empty constituents. Then $\square Z$ is the union of remaining k-1 constituents. Now by the proposition 1,

This gives our implication.

(ii) =>(i) Assume Z is not describable. This means $\underline{Z} \neq \overline{Z} \neq \overline{Z}$, Assume again that \triangle has k nonempty constituents, $\triangle \cap Z$ has 1 nonempty constituents. Consider set $FrZ = \overline{Z} - \underline{Z}$. Since it is nonempty and describable it is the union of at least one constituent. Assume it is union of m constituents. Now $\mathbb{B}(\triangle \cap Z)$ has 1 constituents and $\mathbb{B}(\triangle \cap Z) \times \mathbb{B}(\triangle \cap Z)$ has k-l+m constituents. Thus the product $\mathbb{B}(\triangle \cap Z) \times \mathbb{B}(\triangle \cap Z)$ has k+m generators and so is not isomorphic with $\mathbb{B}(\triangle)$ since the latter has k generators.

The proof of this fact follows from the proposition 1. Now let 00 be the largest selective definable restriction of Δ and let Δ_1 be $\Delta((X_3, X_3))$. According to the definition of Δ_0 and proposition 1 every constituent of On consists of at least two elements. Moreover $\mathcal{B}(\mathcal{S}) \cong \mathcal{B}(\mathcal{S}) \times \mathcal{B}(\mathcal{S}_1)$. The system \mathcal{S}_1 is called totally nonselective. Our remarks boil down to the following:

Proposition 8: (i) There is a unique decomposition of the system \(\) into selective definable restriction \(\) \(\) and totally nonselective definable restriction \(\chi''

(ii) In the above situation we have, for every $Z \subseteq X$

(ii) and (iii) follow by propositions 6, 7 and 3 It follows from the proposition 8, that the operations . and

are of interst only for the totally nonselective systems (which just means that Hausdowff part of the corresponding topological space is empty).

Proposition 9: If 3 is totally nonselective then there exist sets Z and T with the following properties

Proof: Choose Z to be a selector of constituents of and T its complement. Theorem 10: Let \(\shcape \) be totally nonselective and C, D describable subsets of X_{2} , moreover $C \subseteq D$. Then there exists $Z \subseteq X$ such that $\underline{Z} = C$ and $\overline{Z} = D$.

Proof: We follow the construction of the proposition 9. Consider DNC split it into constituents and let T be a selector of these. By total nonselectiveness none of the constituents of DNC is included in T. Thus CUT = D whereas CUT = C.

The result of the theorem 10 is used to characterize the algebra $\mathcal{F}(\mathbf{X}_{5})/\approx$ • Since $\mathbf{Z}_{1}\approx\mathbf{Z}_{2} \iff \overline{\mathbf{Z}}_{1}=\overline{\mathbf{Z}}_{2}$ & $\overline{\mathbf{Z}}_{1}=\overline{\mathbf{Z}}_{2}$ therefore an equivalence class of the relation pprox is determined by the pair < C,D > of describable sets such that C & D. Now by

the theorem 10, in totally nonselective system each such pair determines an equivalence class (of Z's such that Z = C and Z = D). Let us introduce now, in the set of pairs Z = C and such that Z = D the operations "coordinate-wise". By the results of Traczyk Z = D and Dwinger Z = D the resulting structure is a Post algebra with 3 generators which is naturally related to the three-valued logic. It is far from being strange since the elements of Z = D (i.e. those x's which Z = D are in Z = D with value 1, the elements of Z = D are in Z = D with value 1, the elements of Z = D are in Z = D with value 0 whereset the elements of Z = D belong to Z = D with value 0 whereset the elements of Z = D belong to Z = D with value 1/2 since they are undistinguishable (from the point of view of Z = D) from some elements which do not belong to Z = D.

Let us finally note that the algebras $\mathcal{O}(X)/\infty$ and $\mathcal{O}(X)/\infty$ are isomorphic to $\mathcal{B}(\Delta)$.
